## Samuel H. Slosberg

GARDINER — Samuel H. Slosberg died peacefully Monday, Sept. 28, 1998.

Sam was born in Randolph on May 12, 1910, the son of Louis and Sophie Dion Slosberg. The family moved to Gardiner six months after his birth and became an integral part of the business and social community of the city. His parents were well-known for the clothing and shoe stores they opened in 1910 in Gardiner and were very active in the Jewish temple.

In 1926, Sam was a member of the first class to graduate from the then-new high school on School Street. He attended Bowdoin College and graduated cum laude in 1930. He went on to Harvard Law School, graduating in 1934. He was admitted to the Maine Bar and established a law office in Gardiner in 1935.

Shortly after opening his law office, Sam married the former Lynn Weitz of Weehawken, N.J., in October 1936. Gardiner has been their home for the past 62 years.

Sam served as president of Temple Beth Israel in Gardiner for many years. When Temple Beth El was opened in nearby Augusta, the Gardiner congregants joined that temple.

Sam was a man with many community interests. He served on the board of Gardiner General Hospital, was the first president of the Young Republican Club and was a delegate to Republican state conventions for countless years. Sam had musical talent and played violin while in high school and for many years played with the Augusta Symphony.

In 1974 "Mort" Havey, executive director of Associated Industries of Maine, heard of Sam's pending retirement and wrote him stating: "I believe it behooves you morally and legally — to write an amendment to the retirement laws of Maine stating: It shall prohibit any faithful servant of such distinguished ability, high integrity, outstanding personality and loyal friendliness as Samuel H. Slosberg from ever severing official state relationship before 100 years of age." With the Slosberg sense of humor, there was a response but it was not recorded.

Just days before his death, Sam received word that Cedars Nursing Care Home in Portland had received a valuable collection of 15 oil paintings "in appreciation and gratitude to honor Samuel H. Slosberg, recognizing his contribution of overseeing legislation that protected the people and the constitution of the state of Maine." The gift was given anonymously.

Sam leaves his devoted wife; sons, David of Paris, France, and his companion, Annie Heideiger and grandsons, Jared and Adam; Kenneth of Santa Cruz, Calif., and his wife, Bertine and granddaughters, Rebecca and Sophie.

A private family burial will be Friday in Portland. A memorial service will be 11 a.m. Sunday at Temple Beth El in Augusta.

When his legislative term expired, he assumed the duty of aiding state departments in preparing bills for upcoming Legislatures. In addition, he served as an assistant state revisor of statutes. In 1943 he was appointed assistant attorney general.

A newspaper article in February, 1945, stated: "Samuel H. Slosberg of Gardiner, the present revisor, has shown marked ability in his present, part-time status; he should prove invaluable to the state administration, to practicing attorneys and indirectly, to the public in the full position he will assume."

From that day until he retired in 1974, Sam lived up to all that was expected of him in supporting the workings of the Maine government and the Legislature.
