# Treatment Of Jews In Russia To Benefit Center Day Camp

The hue and cry engendered by the Soviet highjacking trials seems to be bearing fruit. The two death sentences have been commuted, even though these prisoners face, instead, fifteen years at hard labor. In addition, the sentences of three others have been reduced. The severity of the original sentences brought protests and appeals for clemency by government, religious and lay leaders all over the world which, reportedly, caught the Soviet authorities by surprise.

There was no actual highjacking. The 11 sentenced in this first trial were arrested on charges of plotting to highjack a plane to Israel. And this is far from the end. Other trials are in the offing, show trials that will, in all probability, become an instrument for reminding other Russian Jews of the futility of attempting to leave the Soviet, and which may make these first trials seem comparatively lenient.

On the last day of this year, 400 Jewish leaders converged on our nation's capitol. Portland's own Rabbi Morris Bekritsky, Vice President of the Rabbinical Council, was among them. The group was coordinated by the American Jewish Conference on Soviet Jewry and the Conference of Presidents of Major American-Jewish Organizations. Many non-Jewish as well as Jewish political and civic leaders addressed the group. 48 congressional signatures were collected on an appeal to Soviet Ambassador Anatoly Dobrynin, and a number of Senators have called for action by President Nixon on behalf of Soviet Jewry.

In addition to all the activity emanating from Washington, formal protests were lodged by Britain, France, the Vatican, West Germany, Denmark, Norway and Austria. In Israel, where (understandably) feelings ran especially high, an entire session of parliament was devoted to protesting the highjacking trials and the manner in which Israel could make her displeasure known to the entire world.

Here in Portland, Mrs. Harry Z. Sky is Chairman of the Jewish Federation's Committee on Soviet Jewry. She and her committee have been planning various activities geared to protesting the treatment of Soviet Jews. Letters appealing for action have been sent to our congressmen, senators, President Nixon and Soviet Ambassador Dobrynin over the signature of Sumner T. Bernstein, Federation's president. Also, Rabbi Harry Z. Sky and Jerry Slivka recently were heard on Radio Station WGAN's Main Line program where, for two hours, they discussed the plight of Soviet Jewry with all callers.

It would seem that every one of us has his work cut out for him. We must continue to bombard our Senators and Congressmen, the Russian Ambassador and even President Nixon with letters and telegrams protesting these trials and the severity of the sentences imposed on these unfortunate Jews whose crime is a desire to leave Russia and emigrate to Israel, where they may live as Jews.
